Hiring update:

We received a total of 20 applications, 19 for a full-time position and one for a non-paid position. All of the applicants met the minimum requirements. On Tuesday Nov. 17 @ 5:30 pm we will be administering an entry level test for the applicants. We will proceed with background investigations on those that pass the test. We hope to be able to hire by early December. This is the first time we had the website up and applications available online. This was a great tool; not only were applicants able to download the application but they were also able to obtain information on the department and the city.

Fire Marshal Update:

- Met with City Atty. and developed plan for addressing serious code violations.
- Investigated one vehicle fire at H.E.B.
- Issued 2 burn permits

Animal Care and Control:

I am glad to report that we now have the animal control pickup. It should be outfitted and in service within the next 7-10 days.

The following data was provided by A.C.O. Bill Dixon:


- Picked up 18 dogs
