Please Note: A \$50.00 deposit is required with this application to help defray the costs. Deposit will be refunded, once the mobile home has been placed on above described property and been inspected and approved by building inspector.

SECTION B.

*** The following was taken from the Mobile Home Ordinance, #93:

Ordinance #93/Section 8./Construction Standards:

Before a request to locate or maintain a mobile home outside of a duly licensed and lawful mobile home and/or travel trailer park in the CITY OF LYTLE is granted, it must be shown by the person making said request that the subject mobile home has met, or is capable of meeting, the Veterans Administration's or the Federal Housing Administration's standards for Mobile Homes.

** The Mobile Home Dealer from whom you are buying your Mobile Home can provide you with a letter stating that the Mobile Home does meet or is capable of meeting VA or FHA standards for Mobile Homes.

Ordinance #93/Section 9./Requirements:

- A) The wheels of the Mobile Home must be removed.
- B) If the tongue of the Mobile Home is not welded to the Mobile Home's frame, it must be removed.
- C) The Mobile Home must be anchored according to the anchoring standards adopted by the Texas Department of Labor and Standards.
- D) The Mobile Home must be skirted.
- E) The Mobile Home must be connected to City utilities, if the utilities are available.
- F) The Mobile Home must be equipped with a smoke detector that has been approved by the Fire Marshall of the Lytle Volunteer Fire Department.

The granting of any request to locate or maintain a Mobile Home outside of a duly licensed and lawful Mobile Home and/or travel trailer park in the CITY OF LYTLE shall be conditioned upon the above requirements being complied with within sixty (60) days from the date the request is granted. Failure to comply with all of the requirements listed in this Section within the stated time period shall constitute a violation of this Chapter. Each violation of this Chapter shall be punished by a penalty of a fine not less than One Dollar (\$1.00) nor more than Two Hundred Dollars (\$200.00). Each day such violation continues shall be a separate offense.

*** Please reread A) thru F) very carefully. If your application is approved and you are granted permission to place your mobile home on your property, you will be fully expected to comply with each and every requirement stated in A) thru F). If you do not totally understand what is expected of you in regards to these requirements, please call the Lytle City Office, and it will be further explained to you.
