

ORDINANCE # 22-02

AN ORDINANCE OF THE CITY OF LYTLE AMENDING ORDINANCE NO. 98 AND 140 AND SECTION 2-127 CITY SECRETARY POWERS AND DUTIES OF THE CITY OF LYTLE CODE OF ORDINANCES; INCORPORATING RECITALS; PROVIDING A REPEALER; PROVIDING FOR SEVERABILITY; AND SETTING AN EFFECTIVE DATE

WHEREAS the City Council of LYTLE adopted new City Secretary powers and duties at its June 13, 2022 Regular City Council Meeting;

WHEREAS the City Council wishes to amend Ordinance No. 90 and 140 and Section 2-127 Powers and Duties of the City Secretary; and

WHEREAS the City Council of Lytle finds it in the best interest of the city to implement the new powers and duties adopted for the City Secretary position; and

WHEREAS, effective immediately following the adoption of this ordinance by the City Council of the City of LYTLE, the City Secretary duties and powers shall remain in effect unless otherwise changed by the City Council; NOW **THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LYTLE THAT CITY SECRETARY POSITION POWERS AND DUTIES ARE AMENDED AS FOLLOWS:

SECTION 1. At the Regular Meeting held on June 13, 2022, the City Council adopted new powers and duties for the position of City Secretary, in addition to those powers and duties statutorily provided by Local Government Code Section 22.071, 22.072, 22.073 and as provided by State Law. The powers and duties are as follows in attached **Exhibit A** job description for the City Secretary incorporated herein for all purposes.

SECTION 2. INCORPORATING RECITALS

The City Council approves the recitals to this ordinance contained in the preamble hereto and incorporates them herein as findings of fact.

SECTION 3. REPEALER

All other ordinances, resolutions or parts thereof in conflict herewith are repealed to the extent of such conflict. All procedures adopted prior to the approval hereof are ratified and saved from repeal through the effective date.

SECTION 4. SEVERABILITY

If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional or illegal, such decision shall not effect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared void.

SECTION 5. EFFECTIVE DATE. This ordinance shall be effective immediately and shall remain in effect unless otherwise changed by the City Council.
